These booths are located in the Casper, Torrington, and Cody libraries.</li> <li>○ This project has been a partnership with the College of Education and Dr. Amanda DeDiego.</li> <li>○ Additional funding has been received to support this initiative. Telehealth booths will be installed in three other libraries throughout the state. Qualifying families will be provided with a Samsung tablet and 60 days worth of service. After the 60 days, they can choose to continue service, but they do not have to give the tablet back. Mel Arthur, Director of Education Excellence, Wind River Family and Community Health Care

- Recipients must make at least 100% of the federal poverty level (based on family member or family size), are not incarcerated, and don't have a qualified health plan through their employer or other means, they could qualify for those advanced premium tax credits.
- Currently the marketplace in Wyoming works with Blue Cross Blue Shield, Mountain Health Co-Op, and may include United Healthcare in the future.
- Open enrollment starts November 1<sup>st</sup>.
- **Wind River Family and Community Health Care Updates**
  - Intertwining their telehealth program with their distance learning and their community health aid program and mobile units.
  - Wind River Family and Community Health Care has turned into a 638 contract program. There are currently over 500 employees and 23 programs.
  - The Wind River Indian Reservation is home to the Northern Arapahoe and Eastern Shoshone tribes. The current population of both tribes is about 13,000-15,000 people.
  - This population has the worst healthcare disparities in the state, and a lot of that is due to lack of access to healthcare.
  - The Community Health Aid program currently certifies community health aids to operate within the reservation. They will be certified at the regional level and then will be able to collect Medicaid and bill Medicaid once the whole system is in place.
  - Currently have four mobile units (not built for off road, though). Each one has a Starlink.
  - Collaborating with the Housing Coalition to start building multigenerational housing where it's about continuity of care for the elder.
  - Have distant learning for healthcare professionals and community members and telehealth services for schools, casinos, senior centers, and community halls.
  - Applied for a grant to bring equipment to 14 different locations on the reservation to provide telehealth services and a distance learning training hub.
  - Will be doing digital storytelling with the education excellence program. A lot of the stories will be available on YouTube.
  - Have access to Canvas so trainings can be developed. Behavioral health trainings are already developed.
  - **Some challenges include:**
    - Connectivity issues. The reservation now has access to broadband.
    - Securing sustainable funding.
    - Building trust in the community.
